The purpose of this letter is to inform counties of a redistribution of \$1.1 million in FY 2005/06 CalWORKs Single Allocation funding. These funds are being redistributed as requested by the County Welfare Directors Association (CWDA). The CWDA determined the redistribution of funding amongst counties to ensure the maximum expenditure rate of available funds. The attached spreadsheet displays the redistributed FY 2005/06 CalWORKs Single Allocation funds.

Please note that the redistributed funds have been added to counties' total Single Allocation rather than to any of the individual components within the allocation. Counties are reminded that Single Allocation is essentially a block grant and that they have the flexibility to use the funds interchangeably between individual components.
