THE CALIFORNIA WORK OPPORTUNITY AND

RESPONSIBILITY TO KIDS (CalWORKs) PROGRAM

REFERENCE: CFL No. 06/07-11, Dated July 28, 2006

This letter is to notify counties of the final Single Allocation for the CalWORKs Program for FY 2006/07. A total of \$1.7 billion in federal Temporary Assistance for Needy Families (TANF) funds and State General Funds (SGF) was made available upon approval of the FY 2006/07 Budget Act. The CalWORKs Single Allocation includes funding for the following program components: Eligibility Administration, Welfare-to-Work (WTW) Employment Services, Cal-Learn, and Stage One Child Care.

The CalWORKs planning allocation utilized expenditure data for the most recent four quarters available at the time of completion (the fourth quarter of FY 2004/05 and the first three quarters of FY 2005/06). The final CalWORKs Single Allocation has been updated to incorporate expenditure data for the four quarters of FY 2005/06. As stated in CFL 06/07-11, ten percent of the planning allocation was provisional, pending adjustments related to fourth quarter expenditure data.

Attachment I presents a summary of the final CalWORKs Single Allocation in federal funds and SGF. Attachments II through V display the detailed allocation for each program component: CalWORKs Eligibility Administration, CalWORKs WTW Employment Services, Cal-Learn, and CalWORKs Child Care. For a brief description of the allocation methodologies used for the components in Attachments II through V, as well as a complete listing of program codes for the CalWORKs Single Allocation, please refer to CFL 06/07-11, Attachments VI and VII respectively.
