WORK OPPORTUNITY AND RESPONSIBILITY TO KIDS
(CalWORKs) SINGLE ALLOCATION – CHILD CARE

The purpose of this letter is to inform counties of an augmentation to the FY 2006/07 CalWORKs Single Allocation. The allocation has been increased as a result of the Department of Finance's approval of a request for Child Care funds from the Temporary Assistance for Needy Families (TANF) Reserve. A total of \$8,133,499 in Reserve funds is being allocated to counties that demonstrated a need for additional child care funds. Demonstrated need was determined by comparing each county's FY 2006/07 CalWORKs Child Care allocation and Single Allocation to actual and projected expenditures. The attachment displays counties' Child Care augmentation and revised total FY 2006/07 CalWORKs Single Allocation.
